**District 12: Gary A. Delaney, MD,** elected in 2018. Eligible for one additional term. Nominated by District 12 for fourth term. *(Regular election)*

**District 14: Forest “Cleave” Ham, MD,** elected in 2022. Eligible for two additional terms. Nominated by District 14 for third term. *(Regular election)*

### OFFICERS

The following seats are open for nominations:

**President-Elect:** Elected annually. *(Henry F. Butehorn, III, MD will seek position.)*

**Secretary:** Elected annually, limited to three consecutive terms. *(H. Timberlake Pearce, Jr., MD elected in 2022. Eligible for one more term. Will seek reelection.)*

**Speaker of the House of Delegates:** Position is limited to three terms. *(Jeffrey P. Cashman, DO, elected in 2022. Eligible for two additional terms. Will seek reelection.)*

**Vice-Speaker of the House of Delegates:** Position is limited to three terms. *(Stefanie M. Putnam, MD, served 2017-2019; 2020-2021. Eligible for one additional term. Will seek reelection.)*

Reelected in 2022 to serve 2023–2024. *Will seek reelection in 2024 to serve 2025–2026.*

**Bruce A. Snyder, MD**, elected in 2014 to serve as an Alternate Delegate in 2015–2016. Reelected in 2016 to serve 2017–2018. Moved to Delegate in 2017 to fulfill Dr. Boyce Tollison's term upon his retirement. Reelected in 2018 to serve 2019–2020. Reelected in 2020 to serve 2021–2022. Reelected in 2022 to serve 2023–2024. *Will seek reelection in 2024 to serve 2025–2026.*
