Submission / Idea*

While the SCMA has identified "Expanding Access to Care" as an advocacy priority, it has not endorsed Medicaid as the most effective means for achieving this goal. With devastating budget cuts looming, the SCMA should emphatically communicate its support for the Medicaid program to policymakers and the public.

Evidence / Support for Proposal*

(1) Medicaid is a lifeline for more than 1.1 million low-income adults, children, pregnant women, elderly adults, and individuals with disabilities in South Carolina. (2) Research consistently shows that Medicaid coverage improves health outcomes for individuals, families, and communities and is associated with reduced mortality for children and adults. (3) A recent Kaiser Family Foundation poll indicates that over half of adults report having Medicaid coverage for themselves or a family member. Additionally, a significant majority view Medicaid positively, regardless of party affiliation. (4) South Carolina is one of 10 states that has not accepted Medicaid expansion funds and has a larger uninsured population than the national average. (5) Proposed reductions in Medicaid funding will exacerbate existing healthcare disparities and threaten the financial survival of rural hospitals and physician practices.

Requested Action: What action is required to achieve this idea?

The SCMA will make "Expanding Access to Care Through Medicaid" a top advocacy priority. The SCMA will oppose federal and state efforts to reduce Medicaid funding or restrict eligibility. The SCMA will acknowledge its support for Medicaid to the Governor, members of the Legislature, relevant state agencies, the news media, and other appropriate organizations.

Why is the Requested Action important?*

The South Carolina Medical Association's mission is to "improve the health of all South Carolinians." Expanding access to quality, affordable healthcare through the Medicaid program is essential to achieving this aim.
